### **Privacy Policy**

At t0ns.com, we respect your privacy and are committed to protecting your personal data. This Privacy Policy explains how we collect, use, and protect your data when you visit our Website or contact us through our online form.

For the purposes of data protection laws, the data controller is Oben Club GmbH, a company incorporated under the laws of Switzerland, with its registered office at Dammstrasse 16, Zug, 6300.

#### 1. Information We Collect

When you visit our Website, our servers automatically record certain information sent by your browser ("Log Data"). This may include your IP address, browser type, referring domain, and other technical information. For most users, the IP address changes periodically and does not directly identify you. We use this Log Data solely for the technical administration and maintenance of our Website.

When you submit a message through our contact form, we collect the following information: full name, email address, company name and message content. We use this information to respond to you and, where appropriate, to provide updates about our products, services, or changes to our Terms or Privacy Policy.

Like many websites, we use cookies and similar tracking technologies to collect additional information about how you use our Website. This helps us enhance functionality of the Website, tailor content, and improve your overall user experience.

# 2. Types of Cookies We Use

Cookies are small text files placed on your computer or mobile device when you visit our Website. They enable our server to remember certain information about your activity, preferences, and settings, helping us tailor the Website to your interests and improve your user experience.

Cookies may collect information such as your device's IP address and browser type, general location, the referring URL, pages visited, time spent on the Website, content or ads viewed or clicked, and other browsing activity. This data helps us analyse how you use the Website and enhance its performance. Some cookies may also support behavioral advertising, allowing us or third parties to display ads that are more relevant to your recent searches or browsing habits.

We use the following types of cookies on our Website:

**Strictly Necessary Cookies.** These cookies are essential for the secure and proper operation of the Website. They enable core functionality such as page navigation and access to secure areas. They do not collect any personal data, track your browsing activity, or remember your preferences. Because they are necessary for the Website to function, these cookies cannot be disabled.

**Functionality Cookies.** These cookies allow the Website to remember the choices you make (such as language preferences or the last page visited) and provide enhanced, more personalised features. The data collected is usually anonymised and not used to personally identify you. While not essential for the Website to function, these cookies improve your overall user experience.

**Analytical Cookies.** These cookies help us understand how you interact with our Website by tracking metrics such as the number of visits and unique users, pages views, time spent on each page, and links clicks. We use trusted third-party analytics providers, such as Google Analytics, to collect this data. This data allows us to measure and improve the Website performance. The data collected is usually anonymised, does not personally identify you, and is used solely for statistical purposes.

Targeting or Advertising Cookies. These cookies may be set by us or by our trusted advertising partners to deliver content and ads that are more relevant to your interests. They track your browsing history and building a profile of your online behavior. This process, known as behavioral advertising, helps infer demographic information like age or gender and ensures that the ads you see are more personalised. We also use these cookies to manage our advertising relationships, including tracking how many users have viewed or interacted with a specific ad, or visited a particular page through an ad.

Our approved advertising partners, such as Google (including Google DoubleClick and AdSense), may place these cookies on your device to help deliver targeted ads and manage advertising metrics.

### 3. How We Share Collected Data

Whenever we share your personal data with third parties, we take appropriate measures to ensure that your data remains confidential and is used only under this Privacy Policy. These measures include working only with trusted service providers, entering into data protection agreements with our contractors and partners, and implementing technical and organisational measures to protect data.

**Contractors and Partners**. We may share your personal data with our contractors and service providers, including those located outside the European Economic Area (EEA). For example, some of our contractors operate in Ukraine. Any international transfer of your personal data is carried out in compliance with applicable data protection laws, including through the use of Standard Contractual Clauses approved by the European Commission to ensure an adequate level of protection.

**Third-Party Advertisers**. We work with third-party advertising providers to show relevant ads when you visit our Website. These providers may collect certain information about your activity on this and other websites to display you ads that match your interest. This information does not include data that directly identifies you, such as your name, email address, or phone number.

Our advertising partners include services such as Google Analytics, Google DoubleClick, and Google AdSense. Please note that this Privacy Policy does not apply to the cookies used by these third parties. **Legal Compliance.** We may disclose your information where required by law, applicable regulations, or government requests, or where we believe it is necessary to investigate, prevent, or address potential illegal activity, fraud, or security threats, or to protect the rights, property, or safety of the Company, our users, or the public.

# 4. How You Can Manage Cookies

You can delete cookies from your device at any time. You can also manage your cookie preferences through your browser settings. Most browsers support a feature called "Do Not Track" or "Global Privacy Control", which sends a signal to websites indicating that you do not want to be tracked. However, no method of transmission over the Internet or electronic storage is completely secure. While we take reasonable efforts to protect your data, we cannot guarantee absolute security. By using the Website, you acknowledge and accept this risk.

# 8. Children's Policy

Our Website is not intended for use by children under the age of 18. We do not knowingly collect personal data from children. If we become aware that a child under 18 has submitted personal information without parental or guardian consent, we will promptly delete such data.
